Project Justification: I-5 is one of the most congested corridors in California. Designed to carry 175,000 vehicles a day, I-5 vehicle volumes are now over 275,000 per day and will exceed 500,000 per day by 2030. This heavy volume has caused traffic flow, economic and health issues for the cities of Downey, Commerce, Norwalk, Santa Fe Springs, Buena Park, and La Mirada and has affected goods movement and commerce throughout the region. The project will widen the highway from existing 6 and 8 lane portions to 10 lanes, or 5 lanes in each direction, including a High Occupancy Vehicle

(HOV) lane, relieving traffic congestion and helping respond to the #1 public health issue raised at community meetings. This project is of regional/federal significance. This Project would provide continuity with I-5 to the south, where the highway has been widened. I-5 is an interregional highway of national significance, included on the national defense highway system, and is used for commercial goods movement and passenger/commuter traffic, connecting the U.S. with both Mexico and Canada. Project Justification: The City of Bell is proposing to make significant improvements to the intersection of Wilcox and Florence Avenues. This is a critical intersection within the City of Bell, and over the years has grown increasingly busy, particularly with heavy trucks and transit busses. Because of this high volume of traffic, the pavement of the intersection has been significantly damaged. The City has repeatedly fixed the pavement with temporary patches, but a complete re-paving is needed. The City proposes to replace the existing asphalt patchwork with approximately 9,600 sq. feet of concrete, which is estimated to last 50 years or more without replacement. The increased traffic in combination with the current poor road conditions have led to continual traffic back up at the intersection and virtual "stand still" situations during the morning and evening rush hours. These back ups are not only an inconvenience for residents and business interests in the City, but also a health and environmental hazard as harmful emissions are continually released into the air in high concentrations as vehicles sit idling. To mitigate this situation, the City plans to synchronize the traffic signals in this area along Florence and Wilcox Avenues to improve the traffic pattern and reduce congestion. The synchronization, modernization and pavement replacement at Florence and Wilcox Avenues will improve commuter times, improve parcel service pick up and drop offs, encourage economic development, and an improve service for many of the transit dependant constituents in the City. The City of Bell currently has one of the largest transit dependant populations in the County of Los Angeles. Many residents rely on public transportation to get to and from work, as well as for their daily shopping, medical appointments, etc. These improvements will help the City of Bell encourage public transportation use, improve regional traffic flow, as well as contribute to better air quality and health by lessening the amount of time vehicles spend idling in traffic. In addition, constituent complaints about congestion at that intersection will be addressed.
